In preparation to teach Boy Scouts the requirements of fly-fishing merit badges, several members have become merit badge counselors with the Catalina Council, BSA. We plan to teach the requirements at BSA Camp Lawton in the Catalina Mountains during the week of July 9 - 13. The exact days, times, and topics to be taught have not yet been set. However, volunteers must be registered as merit badge counselors and certified "safe" with a 22-minute, on-line course. Several members are certified so far. Arizona Game and Fish Department NEWS RELEASE For immediate release, April 16, 2012

Game and Fish Stocks Nearly 2,000 Fish to Pena Blanca Pena Blanca Lake

NOGALES, Ariz. - The Arizona Game and Fish Department stocked a total of nearly 2,000 largemouth bass, redear and bluegill sunfish, and channel catfish Friday to Pena Blanca Lake, marking the beginning of an effort to reestablish those populations there following a dredging project by the U.S. Forest Service.

"Timing is everything when stocking fish, and the timing could not have been better in this case," said Fish Program Supervisor Don Mitchell of Game and Fish in Tucson. "It just so happens that the department is ready to begin the renovation of its Bubbling Pond warm water fish hatchery, and the current resident population of warm water fish had to be moved to facilitate the project. Luckily, we were first in line to receive these fish, and I think the anglers are going to be very excited about the quality of the fish we were able to stock."

The fish that were stocked today included several channel catfish weighing between 15 and 20 pounds each, largemouth bass of various sizes, and even a redear sunfish that may be a new state record. Game and Fish is reminding anglers that all largemouth bass caught there must be released alive immediately. This regulation change was made to allow for stocked fish to mature and reproduce, speeding up their reestablishment at Pena Blanca Lake.

"One of the major challenges with this project is balancing the needs of the angling public with that of native Chiricahua leopard frogs found in and around Pena Blanca Lake," said Regional Supervisor Raul Vega of Game and Fish in Tucson. "We are committed to protecting Chiricahua leopard frog populations, and it is imperative that American bullfrogs not become reestablished at the lake."

Game and Fish is taking steps to prevent bullfrog reestablishment there. and it is asking for the public's help as well. Suspected illegal stocking of any aquatic species to Pena Blanca Lake should be reported immediately to Operation Game Thief at 1-800-352-0700.

In addition, all health advisories against eating warm water fish caught at Pena Blanca Lake remain in effect. At present it is not known when those advisories will be lifted, and will be dependent upon decisions made by the Arizona Department of Environmental Quality.

Tips and Tricks

Offset Hooks Catch More Fish

Here's a great tip. When tying a very small fly, slightly bend the hook point to the right or left. An offset hook will increase your number of hookups. Always bend the hook prior to tying the fly in case it breaks. This is also an excellent time to crimp the barb. *From the Rogue Angler website - by David Klausmeyer*

Summer trout stocking schedule goes hi-tech

PHOENIX – Ever wondered where the feisty rainbow trout are stocked along Christopher Creek or Tonto Creek by the Arizona Game and Fish Department? Well, just <u>click here</u>.

Thanks to a new hi-tech online interactive trout stocking schedule just released by Arizona Game and Fish, you can now find out where trout are stocked, especially along streams, and also see maps of the fisheries as well. The full address is: <u>http://www.azgfd.gov/pdfs/h_f/fishing/stocking/2012SumTroutStockSchedule.pdf</u> "Anglers routinely call asking 'where do you stock trout' at one water or another, especially the streams. This interactive stocking schedule goes a long way toward answering that question," said Scott Gurtin, the hatcheries program manager for Game and Fish. The map was Scott's brain child. "Another cool feature is you can enter your starting address and have Google maps show you the way to the fishing spot," Gurtin said.

So not only does the spring-summer trout stocking season kick into gear the first week of April, it's easier than ever to find out where the fisheries are located, how to get to them, and when feasible, know when and where the trout are stocked.

It's time to get your trout fishing gear ready because this is the leading edge of the great spring fishing. "To me, it's pretty exciting. Today's technological advances and applications such as Google maps allow us to better serve our angling customers," Gurtin said. "Be sure to get your 2012 fishing license."

There is also a new interactive online fishing map available at <u>http://gis.azgfd.gov/fishandboat</u> to make it even easier to gather information about fishing locations, and to travel to them.

Don't forget that you can also sign up at <u>www.azgfd.gov</u> to have the <u>weekly fishing report</u> delivered directly to your computer, smart phone or other e-mail-friendly device.

OPTU MEETING MINUTES - MARCH 28, 2012

YOUTH ACTIVITIES/TROUT IN THE CLASSROOM

Joe Fagan reported that he was preparing a letter to the educators regarding next year's Trout in the Classroom program. Discussion was held as to which schools should be notified and how OPTU would chose the schools. Joe indicated that he would be able to handle two schools at any one time.

It was decided that Joe Fagan would prepare a letter to be sent out to all Tucson schools with the emphasis on elementary schools. Roseann advised that she would talk to the principal at Collier School. Further discussion ensued as to who would volunteer to help Joe and the board suggested that once two schools were chosen, perhaps we could call on OPTU members who are within those zip codes.

MEMBERSHIP

Roseann indicated that the national chapter's initiative would be to strengthen leadership through membership. She recommended that we would send a welcome letter to new members, perhaps assign a board member to a new person which would include calling the new member before the next member meeting, and introduce the new member at the meeting and have them do a short intro about themselves.

Roseann suggested that since TU's primary mission was conservation, we should have a short 2-3 minute presentation on conservation at every member meeting. Perhaps also have each meeting sponsored by a local business and have that business donate an item for the raffle.

Board members went on to discuss OPTU patches and shirts as fundraiser for the Chapter. Kathleen V. reported that a patch company was chosen and the patch price would be \$1.15 per patch. The set-up is free. The total cost with shipping would be \$240.00. She suggested that we could charge perhaps \$3.00 per patch and that a patch should be send along with a welcome letter to all new members. A motion was made by Joe V to approve this expenditure and was seconded by Joe Fagan. Patches should be available at the May member meeting.

Joe Vitelli reported that he would be working with company Awards to Go located in Tucson to order tee shirts and 3-button short sleeve polo shirts. The tee-shirts would be a beige color and the polo shirts would be a sage green. The OPTU logo would be embroidered on each shirt. Pursuant to previously voted on amount, the initial expenditure will be \$500.00.

Discussion continued about business cards for board members with perhaps members names and email addresses on the back. Nan prepared business cards for Mike and will look into that.

Kathleen stated that she would do a monthly check of the OPTU member roster which would indicate new members each month. She will be responsible for getting out a new member letter and patch.

MEETINGS COORDINATOR REPORT

Steve discussed Jack Dennis' presentation at the last member meeting. He reported that Jack took ill the following morning and was hospitalized and diagnosed with a heart ailment. Steve reported that there was no raffle at this meeting because members were busy with Jack. Also, the crowd was not as large as anticipated. Steve reported that Jerome Gallegos will be speaking at the April meeting and Dave Brown was scheduled for the May meeting. Steve preliminary indicated that perhaps he could have Pete Nicastro speak at June's meeting.

There would be no meetings in July and August. Steve would be working on a speaker for September and October's meeting would welcome back Jason and Mike form AZGFD for a follow-up on the health of the White Mountains since the Wallow fire.

Robin M indicated that perhaps he could speak with Ty Churchwell for an upcoming meeting. He could discuss hydrology issues and mining in Colorado. Mike M. would check on availability of speakers from the National TU Office.

WOMEN'S INITIATIVES

Nan reported that due to her work schedule and teaching schedule it has been difficult for her to manage additional duties as Women's Initiatives Coordinator. She has not scheduled a women's fly casting clinic as she is awaiting a call back from last years instructors. Nan also indicated that the location of the board and member meetings were making it difficult for her to attend as well since she lives in Marana.

Roseann proposed we research teleconferencing especially for members who have to travel long distances. The board suggested Mike contact TU to see if they have a viable alternative along these lines. The board discussed researching different venues for meetings which would be more centrally located. Nan and Mike will search for options.

Roseann indicated that she would research a casting clinic and would await to hear from Nan with respect to last years teachers.

PRESIDENT'S REPORT

Mike Mehrer reported that due to some health issues and a prior family obligation, he would not attend the April member meeting. He designated Steve as the meeting coordinator. Mike also reported that he will not seek the President's seat after his term ends in December.
