PRESIDENT'S MESSAGE

Greetings Fellow OPTUers:

On Tuesday, March 12, the Arizona Daily Star ran an article titled, "People Have Mixed Reactions About Proposed National Monument". (If you didn't see the article, you can read it here: http://tucson.com/news/state-and-regional/people-have-mixed-reactions-about-proposed-national-monument/ article_6537984e-2d92-5269-9bdo-f2ab1a1e6411.html) There have been no "Letters to the Editor" about this article, and there were no "Comments" posted in the on-line version. If you don't know what this is all about, you are probably not alone.

The "National Monument" referenced is the Grand Canyon Watershed National Monument and lies on the North Rim of the Grand Canyon between the existing Grand Canyon-Parashant NM, the Vermillion Cliffs NM, and the Grand Canyon National Park. Designation of this National Monument means that, essentially, all the public land in ?xml:namespace prefix = str ns = "urn:schemas-microsoft-com:office:smarttags" /Arizona north of the Colorado River between Lake Powell and Lake Mead would be either a National Monument or a National Park.

As with any story, there are two sides. On one side is a coalition of environmental groups and supporters, led by the Center for Biological Diversity and the Sierra Club. Supporters include current and former elected officials, and a large number of individuals and businesses which appear to be mostly from Tucson and Phoenix. There are no sportsmen groups identified as a "supporter" of this legislation. More information about this coalition is here: https://www.grandcanyonwatershed.org . Their position is that the National Monument designation will provide further protections from threats, including banning all uranium mining within the monument, disallow any logging activities in the old-growth ponderosa forests, and remove some roads and fences which impact wildlife migration corridors; encourage not renewing grazing leases (probably by removing fences and roads into grazing areas); protect cultural and archeological areas; and preserve outdoor recreation opportunities including hiking, biking, hunting, fishing, camping, etc., but apparently not off-road vehicle riding.

On the other side are outdoor sportsmen groups, led by the Arizona Game and Fish Department and the Arizona Sportsmen for Wildlife Conservation (more about the AZSFWC here: http://arizonasportsmenforwildlifeconservation.org) Arizona State Council of TU is a member of AZSFWC. Both groups have written resolutions in opposition of the GCWNM. The AZGFD position resolution is here: http://azgfd.net/artman/publish/NewsMedia/Game-and-Fish-Commission-votes-to-oppose-proposal-to-create-Grand-Canyon-Watershed-National-Monument.shtml, and the AZSFWC resolution, which closely mirrors the AZGFD resolution, is here: http://arizonasportsmenforwildlifeconservation.org/

AZSFWC_Resolution_on_Special_Land_Use_Designations_Updated.pdf. These documents largely refute claims made by the Grand Canyon Watershed group and argue against the designation of the proposed National Monument. They are too long to summarize here, so I encourage you to follow the links and read them yourself. Do you have any thoughts, either pro- or con-Monument designation? I would appreciate hearing from you, and I will pass your thoughts on to the State Council. This Monument is not a done deal yet, but supporters are encouraging President Obama to simply designate the National Monument without Congressional review or debate. Don't wait too long to voice your opinion to your legislators.

Our April meeting will be held at 7:00 p.m. on Wednesday, April 1, at the Viscount Suite Hotel on Broadway at Arcadia. The speaker will be Mike Kaul, guide and owner of Two Rivers Emporium in Pinedale, WY. Mike has fly fished for trout in the Wind River Range and the Wyoming Mountain Range for over 45 years. He will provide commentary and a visual experience on the lightly traveled Bridger Wilderness area. His presentation will include discussion of other nearby recreational opportunities. I hope to see you there.


CONSERVATION

Conservation efforts continue to grow in Southeast Arizona. OPTU was awarded an Embrace a Stream (EAS) Grant and will be participating with Arizona Game and Fish on a Partnership Waters Program for Frye Creek and Frye Mesa Reservoir.

The EAS grant is for the purchase of temperature data loggers to assist in the analysis of potential habitat for Gila and Yaqui trout. Once we have a work plan in place I will be asking for volunteers to assist.

The Partnership Waters Program with Game and Fish is an effort to get OPTU more involved in the monitoring of the Gila Trout fishery of Frye Creek, Frye Mesa. Once we have worked out the details one effort we will be to conduct hook and line surveys of the reservoir and creek. More to come.

Board meeting was held at Viscount Suites Hotel and was called to order at 5:05 p.m.

A motion was made by Steve to accept the March Board meeting minutes as prepared by K. Vitelli and seconded by Roseann Marsett.

Roseann reported that the current funds in the OPTU accounts were \$8193 in the money market account and \$10,000 in checking account.
